9. No purchase is necessary to enter, however Entrants that have entered the Promotion will automatically be entered to receive the floor stickers.
10. If the entrants of a pack of floor stickers is unable to accept their floor stickers for any reason, then the Promoter reserves the right to award the floor sticker pack to an alternative registered school.
